Research policy Guidelines

1. Research Ethics

- 2.2 Encourage research activities that are novel and socially relevant. Research output will be a criterion for faculty promotion or incentives.
- 2.3 Based on the provision available the institution will support the faculty in research

- Ensure that the data is free from any malpractice and maintain standards of • publication ethics
- Contribute in the publication if the researcher wants the study outcome to be published
- Acknowledge the institution and other collaborators if included during the study in publications.
- Conduct research activities within the regulatory frame work avoiding any accidental injury to person, respondents or property. Strictly follow the institutional code of ethics.
- Obtain approval from all regulatory boards prior to the commencement of the study.

4. Research Support and Expectations:

- 6.4 The institution will take responsibility in helping the principal investigator in managing the funds.
- 6.5 Source of funding if any will be acknowledged in the publications.
- 6.6 Documents related to sanction of grants, expenses incurred will be maintained by the principal investigator and handed over to the institution research committee through the institutional grant coordinator for accounting purpose and these documents will be periodically audited. Finally, a completion report and the outcome has to be submitted to the research committee.
