1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The **Kunhitharuvai Memorial Charitable Trust (KMCT) Group of Institutions** was established in 1994 by **Dr. K. Moidu,** a leading medical practitioner and a visionary educationist, for imparting quality education in different professional fields.

KMCT is located in the serene hillocks of Manassery and Mampatta around 25 Km from Calicut in Kerala. Away from the commotion of the city, the Campus is set in a lush green and tranquil environment - an ideal place to pursue education. The first institute to come up under KMCT was the National College of Pharmacy in 1994 and from this humble beginning, there are now more than thirteen professional and non-professional institutions under its banner. More than 7000 students pursue their education in the various campuses.

Premier institutes such as National Institute of Technology, Calicut (NIT-C) and Indian Institute of Spices Research (IISR) are situated in a radius of 10 km from the campus which opens up opportunities for various academic and research collaborations.

KMCT Dental College and Hospital was constituted in the year 2006 under the administration of the KMCT Trust . KMCT Dental College is a minority status institution with a mission of serving humanity. The college conducts BDS and MDS courses and is recognized by the Dental Council of India and affiliated to the Kerala University of Health Sciences (KUHS) from 2010.

The institute had begun with the vision of nurturing trained professional manpower and transforming them into a receptive work force to meet the ever changing and ever demanding needs in the field of dental care. KMCT Dental College is unique among dental colleges in terms of full time eminent faculty and strategic location in an integrated green campus. The College is dedicated to providing a positive and creative learning environment to Health care professionals. The College is committed to promote excellence in Dental education, Research and Oral health care with a focus on Community service.

The institute gives paramount importance to provision of infrastructure which is reflected in the highly sophisticated labs, preclinical labs, and advanced instruments and this helps to foster the skills of students. A library spread over 8500 square feet with over 6000 books and 100 plus international and national journals provide a scholarly environment for learning.

Eminent faculties of the institution help polish the amateurs to become competitive dental professionals with a human touch. The constant inflow of patients on an average 400 patients per day to the institution reflects the goodwill of this institution. The adequate number of patients helps the undergraduate and postgraduate students to develop good skills and confidence.

As a part of institutes community service, three satellite dental health centers under the supervision of the college deliver care to the indigent population. Every month 8-12 dental treatment camps are conducted at various schools, rural and tribal areas etc of Kozhikode, Kannur and Malappuram districts.

Various CDE programs by renowned speakers from different parts of the country are conducted for updating students and faculty . The institution also encourages the students to conduct research in various specialties of

dentistry. Dental Bites, a peer-reviewed quarterly journal of KMCT Dental College, publishes various research activities of the students and faculties. The college also shows a keen interest in encouraging the students in their co-curricular activities and sports.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

KMCT Dental Collegeby following course curriculum prescribed and approved by the Dental Council of India and Kerala University of Health Sciences make sure that the students develop the required knowledge, skills,

attitude, and values. Students are given training in pre-clinical and clinical aspects according to the prescribed curriculum and provide a room for Practice Management by training the students in the clinical procedures.UG students undertake field visit to water purification plant, milma plant etc every year. PG from various departments attends internship programs in cancer center, trauma center, cleft clinic etc.

College utilizes campus medicine, LMS platforms like Edpuzzle and Google Classrooms, popular messaging platform like Whatsapp are widely used in effective curriculum delivery. Campus medicine is used for administrative purposes also. Structured feedbacks are taken from students, teachers, Employers, Alumni and Parents, the same is analyzed, and accordingly actions are initiated for the benefit of all stake holders.

Being an affiliated institution the college has a minimal role in curriculum design. However students are exposed to new technologies and procedures through routinely conducted certificate programs. Numerous value added courses are offered to bring in transferability in life skills along with curriculum. Students are encouraged to participate in seminars and workshops conducted by professional bodies. Such enrichment courses help to meet the curriculum deficiency. Thus college considers development of entrepreneurships, employability and personal development of each student of the institute.

Teaching-learning and Evaluation

UG and PG admission in the college is conducted as per the guidelines laid down by government of Kerala based on NEET score. The admission process is transparent and the college conducts induction ceremony for the new entry students and conduct classes in regional languages for the needy. The students are informed of the evaluation process during induction programs.Institute effectively implements mentorship programs for enrichment of academic, extracurricular and personal development of the students. Students will be provided with log book and academic calendar at the beginning of academic year. Curriculum committee of the college sets the academic calendar before the starting of each academic year.

The college provides an encouraging atmosphere for academic as well as extracurricular activities. The college has well qualified faculties capable of handling the prescribed curriculum. The teaching learning process is equipped with The Learning Management System (LMS), and other E-learning platforms. College conducts regular class test, theory viva, chair side viva etc for continuous evaluation. The slow learners are thus identified and are given special care. Opportunities are provided to students in the form of retest to improve their internal marks. The collegehas a well-established library enriched with numerous books and national and international journals and a journal surfing room to access online journals. Advanced learners have a good intellectual resource in the library and can be utilized for their academic enrichment.

KMCT dental college has a well active sports and arts committee to organize extra-curricular activities. The institute emphasizes moral and ethical values in students and teachers. Celebrations during various festivals and commemorative days create sense of unity and responsibility among the students. College arranges faculty development programs and programs on E-learning regularly for both teaching and non-teaching staffs.

The institute prepares an action plan for teaching and learning at the beginning of each academic year. College conducts a continuous evaluation of the academic progress and conducts examination maintaining strict confidentiality and university protocol. The academic progress of the students is communicated to the parents after each internal exam and PTA meetings are conducted regularly.

Research, Innovations and Extension

KMCT Dental College, a "Centre for Research" under Kerala University of Health Science (KUHS) focuses on achieving excellence in the field of research. The College has a well- defined framework for research activities which is overseen by the Research Committee and Institutional Ethical Committee (IEC).

College functions as an incubation center by developing an environment conducive for research. College ensures provision of necessary infrastructure and facilities' such as advanced diagnostic equipment, CBCT, Nemoceph, Implant clinic, Dental Lasers etc for conduct of quality research. To enhance the level of knowledge and skills in areas of advanced dental technology and materials sciences, Research methodology, Intellectual Property Rights, Grants etc., periodic workshops and conferences including eminent guest faculties are organized for training faculty and students. The college has signed MoU's with premium institutes such as NIT, Calicut, and has collaborations with various industries for advanced technical support toconduct high end research. Apart from Post graduate research, Undergraduate research is strongly encouraged through the mentored 'Internship Research Program'. Undergraduate students are encouraged to focus on ICMR task force areas and apply for ICMR-STS projects.

The college management promotes Faculty Research by providing seed money for research projects and incentives for publications, paid conference leaves and help in applying for external funding from agencies such as ICMR, DST etc. Faculty and students are guided to publish their research in journals indexed in PUBMED, Web of Science, Scopus etc. Incentives are provided for higher academic achievements of Faculty such as PhD and fellowships. All research performed abides by the College's Code of ethics and the IEC ensures the ethical conduct of all research.

KMCT Dental College prioritises serving the poor and needy and this is one of the core values imparted to the dental students through their active involvement in all the outreach programs organized under the Department of Public Health dentistry. Oral health care services for underprivileged community are met through periodic dental screening and treatment camps as well as through the satellite clinics of the college. Oral health care needs of the vulnerable populations such as elderly, rural and tribal community, challenged individuals and children are addressed through special community programs. NSS unit of KMCT Dental college works towards creating a greener environment and are actively involved in various relief activities and conducts numerous awareness programs. The College's services to the society have been credited with recognitions and awards from various sections of the community, Government and NGO's.

Infrastructure and Learning Resources

The KMCT Dental college building is well planned which fulfils the criteria laid by Dental Council of India. It has 9 well equipped departments to cater the needs of the patients and of dental education. It has an adjoining medical college and hospital run by the same management in the same campus which helps and guides the patient to the dental college who require dental care. This Institution is accessible to numerous villages from three districts for the desired treatment. The adequate number of patients helps the undergraduate and postgraduate students to develop good skills and confidence.

College has ICT enabled classrooms and smart class room which can accommodate more than 100 students at a time. The lecture halls are shared by all the departments in the programmed manner.College has well-armed clinics and laboratories with high end equipments.Dental hospital has latest 3-D imaging radiography, endodontic microscope, implant, laser clinic, tobacco cessation clinic. A well-established library provides a

scholarly environment for learning. The library automated with KOHA software provides a scholarly environment for learning. The college provides technology enabled learning spaces and computers equipped with high speed internet in the all the departments and the library to augment learning outcomes. The library has access to online learning resources like EBSCO. Eminent faculties of this institution mold the students to become competitive dental professionals with a human touch.

College provides separate hostels for boys and girls in the college premises. For all round development of the students, college has indoor and outdoor sports facilities and gymnasium. The college provides accommodation for staffwith in the campus. The campus has a food court with Restaurant and coffee/tea shops in different places. Surveillance cameras and ample security guards are posted to ensure safety and security of all students and employees. College has biometrics-based entry and exit in the college and in the library.

Student Support and Progression

KMCT dental college promotes student-centered learning, the heart and soul of student's success and empowers students to become self-directed and regulated learners. The college is committed to provide timely student support to create a positive learning experience. These services starts right from the admission process and include academic, technical, cultural and language support. These services foster positive relationship among the students and management.

Specific student support is provided for economically weaker students in the form of scholarships, free ships, fee waving by government as well as the institution. More than 50% of the students were benefitted with the financial support in the last 5 years. Special support is given for SC, ST, OBC students by the government agencies. The institute always attempts to identify economically backward students and provide fee waving in the form of mess and hostel fee.

Institute grooms the students with continuous enhancement of soft skills and personality, language and communication skills. In addition to this college incorporates yoga classes in the academic routine. Special programs are conducted to develop analytical skill, professional development and employability skill development. Apart from these capability enhancement programs, college regularly conducts competitive exam guidance and carrier counseling. Students are encouraged to participate in these events organized by the institute. Eminent speakers from various fields are invited to deliver such sessions. Such programs provide an opportunity for the students to understand the inputs for appropriate personal as well as professional progression.

The college promotes various sports and cultural activities in inter and intra college levels. The students represent the college for many intercollege levels and won awards and medals for their performance. College has a strong registered Alumini association with many members. College has a well active Anti-Ragging Committee, Hostel Committee, Grievances Redressal Cell, Anti-Sexual Harassment Committee enables the healthy functioning of the college. The placement cell of the college conducts various carrier guidance programs and informs job opportunities of the institution and clinics.

Governance, Leadership and Management

KMCT Dental College was established with the vision to be one among the globally acclaimed teaching institutions in dentistry. The vision and mission statement are well deployed in prominent places of the

institute, college website etc. The institute interacts with various stake holders to ensure efficient governance. Execution of specific responsibilities is done through various academic and administrative committees to ensure participatory management in governance of the college. The institute has a decentralized administration and the effectiveness of the governance of institute is accomplished with help of various committees.

The institute is managed by KMCT trust and board of directors. It is headed by the Principal and all 9 departments are headed by senior competent faculty. The head of the department are provided with appropriate autonomy and empowerment in patient service, academics and research. The institute has an IQAC (internal quality assurance cell) to evaluate curriculum, teaching learning process as well as administrative session. The college takes feedback from different stakeholders of the institute about quality of curriculum, enrichment courses, teaching performance and infrastructure. These feedbacks are analyzed and outcome is utilized for future development. The competencies of the faculty are monitored regularly through appraisal system and improved through various professional developmental programs.

Institution has strategic plans and policies to meet the mission and vision of the college. The institute has a fully digitalized account department to manage accounts and to mobilize funds through student fee, treatment charges, trust fund etc. All accounts are audited once in 6 months by internal audit committee and annually by external auditing. Institution provides fund for faculty development programs, college events, infrastructure development and its maintenance.

Institutional Values and Best Practices

KMCT Dental College is very peculiar in providing an atmosphere where all the genders are treated equally. Institute takes initiatives to conduct several gender equity programs for all genders and also have anti-sexual harassment committee in the college to ensure adequate mental health of women. With the rising crime rates in the society, the College has taken various measures to ensure safety and social security in the campus. The college has three tier system of counseling procedure to manage and deal with emotional conflict and personal problems. Facilities like common rooms and day care center are also available within the campus.

At the College, the staff and students belong to a diverse range of age, ethnicities, religions, state and socioeconomic status. Each individual is valued for what they are and thus contributes to the success of this institute. The staff and students function as a unit to create a friendly and stress free environment for the patients as well as for the students. The college proposes a dress code for the students in our institution which gives the students a sense of equity among them.

The institution is committed to do several outreach programs in rural as well as in urban areas so that the students get a sense of responsibility towards the society which inspire many budding dentist of our institution to learn and practice social responsibility skills. The patient outreach programs are organized and conducted under department of public health dentistry.

The three peripheral satellite centers located in rural and urban areas are fully equipped and always ready to serve the needy.

All department receptions are provided with feedback forms to collect the valuable suggestions and complaints from the patients. This feedback system ensures patient friendly atmosphere and zero delay in their treatments.

The institute takes several steps to make the campus ecofriendly such as

- Energy conserving light source such as Solar, LEDs are preferred throughout the campus.
- The staff and students are instructed turn off the ACs, lights, fans, computers, dental equipments when not in use to avoid unnecessary energy wastage.
- Strict measures to promote Plastic and pollution free campus. The institute adopts various measures for the management of degradable and non-degradable waste.
- Water conservation projects like rain water harvesting, open well recharge system, waste water recycling units and green campus initiatives.
- The Institution has disabled-friendly, barrier-free environment.

Dental Part

KMCT dental college was started in 2006 with a sanctioned intake of 50 seats for BDS program with necessary approval from the Dental Council of India. BDS seats were enhanced from 50 to 100 in the year 2011. In the year 2013, it became a post graduate institute by introducing MDS programs in eight specialties with 3 post graduate admission every year. The admission is through NEET qualifying exam. The course curriculum for BDS and MDS is based on the DCI Guidelines.

At first, they get a good orientation to the degree program which aims to give an overall view about the course and an anti-ragging session is also conducted along with white coat awarding. During their study period, theory classes, preclinical and clinical session are conducted after which Students are regularly assessed by conducting periodic class test, end of posting exams, and internal exams.

To work in the clinics, dental materials and personal protection device along with sterile materials are provided. They are given opportunity to work in integrated clinic, tobacco clinic, geriatric clinic etc. not only that, students are also trained in using various high end equipment like CBCT, endodontic microscope, dental lasers, extended application of light based microscopy, and various imaging and diagnostic soft wares.

Students and health workers are always made sure to work in a safe environment by periodically disinfecting the working area and following proper disinfection protocol. To ensure this, registers of Periodic disinfection of all clinical areas, Immunization register of all the care-givers, Needle stick injury record is followed by college.

The development of the staff is also taken into consideration by conducting various faculty development programmes and also encouraging to do research and fellowships. Parallel with academics, students are encouraged in extracurricular activities by conducting college day, art festivals, sport competitions etc. in order to enhance the humanitarian values, dental camps, pain and palliative postings and NSS activities are organized by college, making students an integral part of it with the hopes of bringing out the best human in them.

Curriculum planning:

KMCT dental college follows the course curriculum, prescribed and approved by the Dental Council of India and Kerala University of Health Sciences. The University curricular methodologies make sure that the students develop the required knowledge, skills, attitude, and values to enter the clinical practice. For effective curriculum planning and implementation, college utilizes a learning management system (MOODLE).

Curriculum planning and implementation includes:

- The planning, monitoring and implementation of the curriculum is done through a well-organized curriculum committee.
- Curriculum committee prepare academic calendar of the Institute adhering to the guidelines provided by the affiliating University.
- Curriculum committee prepares the time table for under graduate and post graduate courses and on the basis of the curriculum, the faculty members prepare the schedule of lectures and practical classes and this helps in systematic and timely completion of syllabus.
- Students are being trained in pre-clinical and clinical aspects according to the prescribed curriculum.
- All teaching staff are allotted to the students from first year to final years including interns by the curriculum committee to monitor and encourage the academic and non-academic activities.
- The curriculum committee of the college proposes the suggestions to be made, to the principal for improvement of academic activities after identifying the curricular gaps.

For effective management of curriculum activities KMCT Dental College developed a software 'Campus Medicine' for academic and administrative management.

• It includes modules like academic management, student management, faculty performance and SMS enabled monitoring system which augments effective curriculum planning.

Curriculum delivery:

- Curriculum delivery includes theory classes, demonstrations, and clinical postings utilizing conventional as well as e-learning system-Moodle.
- College has ICT enabled class rooms for delivering lecture classes.
- Preclinical and clinical postings are constantly and effectively monitored by the teaching faculty.
- Thus curriculum provides a room for Practice Management for students in the clinical procedures.

- Continous Dental Education programs routinely conducted in the college exposes the students to new technologies and procedures.
- Clinico pathological clubs conducted by each department expose students to various special clinical conditions and give opportunity to derive proper diagnosis and treatment planning.
- For effective delivery of curriculum college implemented blended learning. Blended learning which combines classroom learning with online learning, helps students to control the time, pace, and place of their learning.
- Syllabus, lecture notes, syllabus-oriented audio clips, videos, Power Point presentations, additional reading materials, messages regarding additional contact classes, assignments, test papers, internal marks are being circulated by using class wise Watsapp groups.

. Evaluation

- The evaluation process of the institution follows the norms laid out by the affiliating university, KUHS.
- Three internal assessment examinations are held during each academic year.
- Before the first internal examination class tests and viva are conducted regularly.
- The internal assessment question papers are based on the previous year's university examination question paper pattern.
- The schedules of these examinations are also incorporate in the academic calendar along with the timetable.
- The Institution, through the faculty in-charges monitors the progress of the students very meticulously and the same is conveyed to the parents at the time of the parents-teachers meeting.
- Through the continuous evaluation system, slow learners are identified and taken care by separate batch in-charges and mentors .
- They provide personalized teaching to improve the performance of slow learners.

- In experimental learning students learn by doing.It includes hands-on laboratory experiments, internships, field exercises, undergraduate research etc.
- Such learning programs promote interdisciplinary learning, career development, cultural awareness, leadership, and other professional and intellectual skills.
- According to the curriculum every student should attend pre-clinical labs and clinics during their course.
- In preclinical labs students will get hands on training on models before entering the clinics.
- After preclinical students start patient care by case history taking, from which they learn the verbal and communication skills.
- In addition to regular college clinics each student will have to attend community screening and treatment camps organized by the college in different villages.
- During internship programs each student has to attend pain and palliative postings.
- In addition to these clinical postings undergraduates are given opportunity to attend casuality as well as minor and major operation theatre.

Integrated /interdisciplinary learning

- The students are taught to approach a clinical case in an interdisciplinary manner so that they are exposed to comprehensive learning and treatment planning.
- Students are encouraged to take up cases with multiple chief complaints so that they will get a better idea about interdisciplinary treatment approach by different departments during case history discussions.
- A monthly clinico pathological club is organized where students and faculties from different departments, present different clinical scenarios and discuss the same.

Participatory learning

- College encourages participatory learning by assigning different topics for students. This will enhance the presentation skill of the student.
- In the clinics of each department, students will have to do case presentation with investigatory findings and final diagnosis.
- College encourages participation of students in conferences and CDE programs both within the campus and in other institutions.

Problem solving methodologies

• The institution implements problem solving methodology by discussing several unique and rare cases as CDE and clinico pathological clubs.

Self-directed learning

• Class assignments and seminar presentations are given on different topics in the curriculum. Students are advised to access the soft and hard copies of books and journals in the library.

Patient centric and evidence based learning

• All clinical subjects are patient centered. During clinincal postings students get opportunity for

patient care.

- During internship undergraduates will have to attend pain and palliative postings and thus will get exposed to terminally ill patients.
- Post graduate students are posted in different hospitals like cancer hospitals, trauma centres, cleft centres, child development centres, plastic surgery and palliative care.

Use of skill and simulation labs

- Mannequins are in the domains of pre-clinical Labs of department of Conservative dentistry, Prosthodontics and Paedodontics.
- Simulations are extensively used in demonstration of CPR procedures and teaching of BLS programs to UG and PG students which is being conducted by Emergency Medicine department which has been made mandatory by DCI.

Project based learning

- The institution has not made any specific stipulation regarding student projects for under graduates. Interns and students are encouraged to undertake minor research projects and to submit them to body like ICMR, DBT, DSIRO etc.
- Research committee of the college encourage undergraduates for research work and the publication of the same in indexed journals.

Role play

• The Department of Public Health Dentistry encourages preparation of and enactment of social messages in the form of small skits, plays and short films by the students.

Response:

Introduction

LMS platforms like Google Classrooms integrated with Edpuzzle and Moodle are used for blended learning. The features of LMS are best exploited for making it as a major teaching-learning tool to disseminate knowledge to our students.College also utilizes "Campus Medicine" a multipurpose software solution for academic and administrative management. It includes modules like academic management, student management, faculty performance and SMS enabled monitoring system which augments effective curriculum delivery.

LMS

- All faculties and students are provided with an individual portal with a unique login ID and password for accessing the LMS.
- Faculties can access only their subject portal while students are provided access to all the subjects of study in that academic year.
- The lecture material is uploaded by the respective faculty at least one week prior to the class session and the same is made available to all the students.
- After completion of each topic the respective staff will assign multiple choice or open ended questions in the LMS platform as a part of continuous evaluation process.

Lecture Halls

• All lecture halls are provided with a laptop connector, wireless internet, overhead projector and collar mikes with speakers. The presentation is projected onto a large white screen.

Other Facilities

- A dedicated Information Technology Department capable of providing both hardware and software support, is available is available when ever needed.
- This department gives required training to the faculties in the usage of basic Microsoft tools to enhance the delivery of lectures.

IT Devices

- All departments are provided with more than one desktop computers and one laptop with high speed internet connection.
- Any academic related work can be carried out with the help of the IT enabled facilities. The computers are inter-linked which enable access of the data/information stored in one place in any other part of the campus.
- All the systems are also equipped with antivirus and web page blocking software which prevent access into non-academic websites.

Technological Innovations

- Our institution also possesses latest technological innovations which assist in the diagnosis of dental conditions like CBCT, OPG, endodontic microscope etc. These computer assisted aids helps in instant diagnosis and effective treatment planning for our patients.
- All the radiographs are instantly uploaded into the server and they can be accessed in any department through the login portal of the X-ray server. An important benefit of this is the saving of time and money by avoiding printing the pages.
- The faculties are also provided access to online library resources from EBSCO Host for updating their knowledge regularly.

2.3.5 The teaching learning process of the institution nurtures creativity, analytical skills and innovation among students

Response:

Introduction

The teaching learning system in the institution ensures development of theoretical knowledge through theory classes and assignments and application of this theoretical knowledge in clinics during the treatment process. As theory classes and treatment procedures in dentistry are interrelated its easier for the students to learn and perform clinical procedures with strong theoretical background. The curriculum ensures that the student gains knowledge to prescribe investigations and analytically analyse them for treatment planning. Skills are developed at arriving provisional, differential and final diagnosis for patient care and treatmentStudents are also encouraged to do clinical procedures in a multidisciplinary approach. Also they will get an idea about comprehensive treatment planning; hereby they can apply the same in their future clinical practice.

Creativity and Innovation

Research

- The institution has a scientific and research Committee which makes sure that all the students are involved in short studies during their academic life.
- The committee allots a group of interns to different faculty advisers of each department. It also monitors and conducts regular meetings to ensure that the research programs are happening in the institution.
- The topic of selection is done by the students based on their area of interest in dentistry. Once the topic is selected the research proposal is presented in front of institutional ethical committee.
- Once approved by the committee the study has to be completed within a period of 6-8 months. The

committee also encourage the students to publish the same.

• Apart from the thesis work prescribed in the curriculum PGs are encouraged and motivated for short studies and publication of the same in journals with high impact factor. This will help the students in their future ventures.

Problem based learning

• Case history are discussed and presented regularly during each department postings by both UG and PG students before starting the treatment procedure.

Student assisted teaching

• Specific topics are given to the students to be presented in class through ppt. After the presentation the faculty in charge discuss the same topic in the class. This promotes active learning.

Analytical skill

- The prescribed curriculum of the institution ensures that the student gains knowledge about various investigations and treatment planning.
- Preclinical teaching and learning utilizingphantom head for restoration and tooth preparation in typhodonts, teeth arrangement in mean value articulator, wax block carving, plaster model teeth preparation, suture techniques improves the analytical skills in students.
- Advanced clinical procedures like Implant placement, laser surgeries, and aesthetic related surgical procedures are also practiced to build clinical skills as well as to master with the technique prior with handling to patients.
- The students have compulsory rotatory internship in all departments and after the completion of their rotation postings the students become well versed with diagnosis, treatment planning and execution of treatment.

All students in their rotary postings get an opportunity to observe the treatment procedures done by faculty and PGs and also assist the faculty and PGs.

2.5.2 Mechanism to deal with examination related grievances is transparent, time-bound and efficient

Response:

Introduction

The internal assessment of each year consists of three internal examinations conducted by the institution followingthe pattern of university exams. It helps the students to familiarize with the questions and frame their answers according to university exam scheme. The tentative dates of these examinations are incorporated in the academic calendar distributed to the students at the beginning of each academic year which provides students adequate time to plan and prepare.

Internal assessment Grievance Redressal

- In the theory class after each chapter important questions for university exams and viva voice will be dictated to the students.
- Assignments will be given on important questions and should be answered like the university model
- After finishing each chapter's one class test will be conducted and weak students will be identified and special attention is given for such students.
- After internal exams the answer sheets are valued and distributed among the students within 1 week of examinations.
- The students are given 1 week time to represent their grievance to the subject in charge.
- If any student has change in marks, the revised score is updated in the records.
- Retests are conducted to improve the internal marks of weak students.
- Students can approach the mentors regarding difficulty in exam preparation and presentation. Proper guidance will be given by the mentors regarding the same.
- During the period from 2015 to 2020, all the representations from students relating to evaluations in internal assessment were assessed and it was found that all the grievances were addressed by the HODs to the satisfaction of the aggrieved students.

University Examination Grievance Redressal

- University exams are conducted and scheduled twice in an academic year by the university
- Normally first university exams are conducted during June and second exam is conducted during December of an academic year
- The students are made aware about the rules, conduct, valuation and grievances redressal system of the university which is available on the university website.

- The students can apply for retotaling of their paper if they are not satisfied with their marks through administrative office.
- Revaluation of answer sheets is not permitted by the university since the valuationsystem is so designed that it eliminates the application of revaluation from the students.
- But the students with complaints regarding their marks have the option to get the copy of their answer sheets from the university.
- This helps the students to get an opportunity to discuss the copy of answer sheet with their mentors regarding their answers and get guidance to improve their performance in the subsequent examination.
- And also students become more aware about the valuation system followed by the university.
- On payment of a prescribed fee the students can apply for retotaling and to get a copy of their answer

Response:

Introduction

The university exams are conducted by the university in which the institution is affiliated and the internal exams are conducted by the institution, following the regulations of the university.

Examination procedures:

- University announces the schedule and prescribed fee in the website.
- Students pay the prescribed fee through RTGS in to the college account and once the student report to the office with sufficient proof of transaction, the office does the registration for the student.
- This minimizes the registration issues faced by the student and the office can effectively register all the students in prescribed time limit.
- The applications are processed by the university and the university uploads the Hall Tickets in itsweb portal which can be downloaded at the college.
- The university uploads question papers in the institution login and the college downloads the same

in coded format 30 minutes before commencement of the examination.

- The required copies of the question papers are taken for the exam as the college is a recognized centerfor all university examinations.
- The examination hall is under continuous CCTV surveillanceduring the examinations and the video coverage of the conduct of examinations is sent to the university along with the answer papers on the same day.
- Also the examination halls are equipped with jammers for the prevention of unnecessary mobile usage.

Processes integrating IT:

- The institution has a university approved examination centre and it is well equipped with CCTV cameras and high speed internet connections.
- Adequate number of computers and printer are available in a room very next to the examination hall to access and download the question paper and take necessary printouts.
- Presence of a highly professional IT team supports the conduct of university examinations free from any ITdifficulties.
- The internal assessment marks are entered in department laptops to ensure the safe documentation digitally.
- Uploading of internal assessment marks prior to the university examinations, payment of university examination fees, download of students' Hall Tickets and question papers at the time of university examinations from the university website, valuation of answer scripts and declaration of results are all fully automated.

University Examination Reforms:

• The reforms in university examinations include video recording of exam conduction, the bar coded answer booklet

Self-Assessment:

- Students are provided with a chapter wise question bank and ask to solve the questions with the help of university approved text books. The solving of question bank is given as assignments and its corrected and verified by the subject incharge
- Also viva is conducted followed with a class test of this assignment to make sure that the students are well read and prepared the subjects for the internal and university exam.
- Open book tests are also conducted for our students to help them gain confidence in their abilities during online examination.

Work place based assessment:

- Numerous dental camps are organized in the institution as well as far away from the institution and it helps the student to treat different strata of society.
- Their clinical work are monitored and evaluated by the faculty incharge who accompanies with the students for the camp.
- Necessary instruction is given by the faculty to the students to improve their quality of work and communication skills with the patient.
- This enables the students to approach a patient more professionally and help them to improve their self confidence.

Program specific learning outcomes

The course curriculum of the Under Graduate and Post Graduate Dental Programs offered by this institute is well designed by the KUHS University and the DCI where in all the programs have its own objective and methodology to achieve the learning outcomes. The entire subjects have theory, preclinical and clinical exercise. To achieve the Program Specific Outcome for the subjects, teachers have to use various Direct or Indirect methods to achieve over all educational objectives.

To find Course Outcome and attainment level of each student the department conducts internal tests ,chair side discussions and unit tests for each subject. On the basis of marks obtained in these tests the concerned department finds the attainment level of each student. The outcome of learning is specific to the following categories of general skill, practice management and the knowledge about infection and cross infection in dentistry. The course outcome will be specific to that course and is grouped as developing knowledge and understanding along with skills and attitude.

The course curriculum for BDS and MDS programs are derived from planning through the academic calendar which has time table, conducting internal examinations and practical classes. The learning process will include both theory and practical which involves patients. The outcome of learning will be assessed through the performance in university examinations. The results from these exams were considered for their understanding and knowledge of the subject and course there by developing their skills for their professional career. Thus aligning learning process to generic learning outcome.

The BDS program includes the basics of human anatomy, physiology, biochemistry, pharmacology and microbiology, development of oral tissues, preclinical training on tooth models for restorations, carving of teeth on wax blocks and also constructing dental prosthesis are practiced prior to handling patients clinically. This helps in ensuring that the students are competent in the outcome of learning process in regard to the outcome of the program enlisted.

As for MDS program, as it is based on particular speciality, the department has come with certain curriculum which implements the required objectives for the related speciality. The academic activities include mainly preparation for dissertation, library dissertations, seminars, journal clubs, case presentations and alos presentations in various national conference and clinical procedures related to their speciality. These activities generate the necessary program outcomes.

- 2. July 3rd or 4th week and November 3rd or 4th week for February exam batch. This follows the 1st and 3rd Internal Assessment examinations respectively.

The roles and responsibilities of the PTA Committee:

- A parent teacher committee was formed to make parents involved in the student's activity which will help students interact better with parents and teachers
- Information regarding student's attendance percentage and internal assessment marks are sent to the respective parents.

Parent-Teacher Meeting

- The PTA meeting is scheduled after publishing internal exam results.
- Parents are given an opportunity to interact with staff about difficulties faced by ward
- Teachers can use this platform to a detail discussion of the student progression problems encountered.
- The internal assessment will help selecting slow learners. The students can discuss their academic/ other difficulties faced.
- A discussion among the committee can help in resolving the problems faced. Once the problems were found they were directed to professional counselling.
- The feedback from the parents is collected at the meeting and the points are discussed at the subsequent faculty PTA report discussion.
- The grievances raised by the parents are discussed and the recommendations are taken up by the committee and redressal is done wherever applicable.

Process following University Examination

- The results of the university exams are send to the official watsapp group which includes students and class in charge. Also letters are send immediately to the parents of failed students once the results are out.
- After the students report back to the institution, a separate time table and special attention is given to ensure that they improve their performance and pass the subject in the subsequent exam.
- Feedbacks are received from the parents in the meeting for the department to take remedial action.
- Besides the regular meetings, special meetings of the parents of slow learners are arranged in each department to evaluate their clinical and academic performance and hence it is ensured that they are well prepared for the university exam.

Outcome

Service to the underprivileged sections of the society and developing holistic students with a touch of humanity is a primary focus of KMCT Dental College, and this is reflected in the college's mission of serving the needy through "Training of students to recognize oral health care needs of the underprivileged and providing them with affordable dental care services". The Department of Public Health Dentistry turns this mission into actuality by actively organizing numerous Outreach activities and programs directed towards improvement of Oral and general health of vulnerable populations, provision of community oral health care services, creating awareness regarding Oral health problems and their prevention among the Public. Dental Students are trained to recognize their social commitments and are actively involved in the outreach programs organized by the department.

The Oral health care services are provided by collaborating with various organizations such as Non-Government Organizations, Local panchayaths, residence associations, welfare institutes, volunteer organizations etc. These activities and outreach programs conducted by the Department of Public Health Dentistry for the rural community, old age homes, orphanages, special population groups have received appreciation from the community and various Government and Non-Government organizations.

In 2015, 2017 and 2019 the Department had received special appreciation from *Kodenchery Grama Panchayath* and *Karassery Grama Panchayath* for their Oral health awareness programs and Dental health camps organized for the vulnerable *Tribal people of Chembukadavu and Thottakkad*.

The Department was well appreciated for the ongoing programs and initiatives taken towards identifying the needs of special children and provision of Comprehensive dental care for the parents, caretakers and special children of *Love Shore Institute* for the Mentally challenged at Pannicode, *Sanjoe Pratheeksha Bhavan Special School* for mentally challenged, Mukkam.

These programs focus on active involvement of the dental students in recognizing not only Oral health and General health care needs of the society but also sensitising students towards environmental concerns. Students are involved in various programmes in the adopted villages, college/school campuses, as well as observation of all National and Internationally relevant days such as *World Health Day, World Water Day, World Environment Day, World Oral Health Day, World No Tobacco Day, National Oral Hygiene Day* etc.

KMCT Dental College has implemented 'Go Green Campus', banning all plastic materials inside college premises and has devised strategies to reduce plastic generation and adopt eco-friendly alternatives. The NSS Unit is actively involved in Suchitwa Missions initiatives and has organized various mass sanitation drive' programs such as *Clean* Campus and under the Government's 'Swatch Bharath Abihyan", cleaning of the premises of Community Health Center at Cherupa, Kozhikode and creating awareness on healthier waste disposal practices.

To educate the community, faculty and students regarding the value of preserving Earth's vital resources KMCT Dental college observes 'World Water Day' and 'World Environment Day' each year by awareness sessions on importance of water conservation, planting saplings, creation of herbal gardens in schools etc.

The College has established a Blood Donors forum within campus and the *NSS Unit* of KMCT Dental College along with the Union batch observes *National Voluntary Blood Donation Day* by organizing Blood Donation Campaigns to create awareness and improve voluntary blood donation services among

students and faculty.

The College continuously strives to improve the Oral and overall health of the community by conducting numerous screening and treatment camps in surrounding four major districts of Kozhikode, Wayanad, Malappuram and Kannur.

- 1. Oral and General hygiene awareness educational programs are organized in the villages, schools and tribal areas to create awareness on health and hygiene.
- 2. Campaigns for young children and adolescents such as awareness sessions on tobacco's harmful effects, No Tobacco Rally's and Tobacco Cessation counselling are conducted on 'World No Tobacco Day'.
- 3. Early screening and detection of premalignant oral lesions and cancers are done in dental camps to aid in the prevention of Oral Cancers.
- 4. Free dental treatment for upliftment of Oral health of the rural, underprivileged and backward communities through satellite clinics and numerous dental camps.
- 5. Specialized Oral health care for challenged children and their care takers of Special Schools of Loveshore Institute, Sanjoe Pratheeksha Bhavan etc.

Villages, schools, special schools, Orphanages, Old age homes, Tribal colonies and vulnerable population such as persons needing palliative care have benefitted from these health care services. As a result, the student's have evolved into compassionate individuals with a strong sense of social commitment to the society.

The KMCT Dental college building is well planned with an area of 184740 square feet which fulfils the criteria laid down by Dental Council of India. It has 9 well equipped departments, to cater to the needs of the patients and education of the students. It has an adjoining medical college and hospital which helps and guides the patient to the dental college who require dental care. A library spread over 14000 sqft with over 6000 books and 100 plus international and national journals provide a scholarly environment for learning

Faculty:

Eminent faculties of this institution mould the students to become competitive dental professionals with a human touch.

Patients:

This Institution is accessible to numerous villages from three districts from where patient can easily approach for the desired treatment. There is a constant inflow of patients on an average 400 patients per day to the institution. The adequate number of patients helps the undergraduate and postgraduate students to develop good skills and confidence.

ICT enabled classrooms and labs:

All classrooms and demonstration rooms have adequate numbers of chairs and tables equipped with ICT enabled audiovisual systems, Computer/ Desktop, LCD projectors. ICT helps to improve student learning and deliver better teaching methods. There are 9 seminar rooms and well equipped 5 pre-clinical labs as per the requirements of DCI. One of the lecture halls is having a smart board.

There aremuseums for self-learning and facilities for clinical learning, learning in community are provided. All the laboratories and phantom head labs are equipped with modern, modular and functional workspaces integrating the student needs. The laboratories are designed with the safety features imbibed in the infrastructure and create an excellent ambiance and atmosphere as stipulated by regulatory bodies.

Learning in community includes conducting dental camps for screening of oral cancer and other diseases of the mouth with community based treatment camps. There is a mobile dental unit with two chairs and all sophisticated instruments which can take the quality dental treatment to the unreached. During Internship students are posted in pain and palliative centre where they are trained to do palliative care for the geriatric and the bedridden cancer and debilitated patients

There is a departmental library in all departments apart from central library. The infrastructure provided is based on the needs as well as the potential for growth in various areas of dentistry. The optimum usage of the same is ensured by inducing a productivity based work culture. The overall academic results and research output reflects optimum utilization of academic related infrastructure facilities. Paramount of infrastructure including highly sophisticated labs, preclinical labs, and advanced instruments foster the skills of students.

4.1.3 Availability and adequacy of general campus facilities and overall ambience

Response:

The Dental college is situated in a picturesque landscape at the foothills of the Western Ghats, It is located about 25 kilometres north-east of Calicut City. The town is bathed in serenity, greenery and calm, placid rivers. The college is well connected from by road and there are enough state and private buses from the city. The railway station and airport is well connected by road. The buildings are constructed with adequate natural lighting and ample air. The campus is eco-friendly.

The Dental College has staff quarters, students' hostel, gymnasium, auditorium, indoor and outdoor facilities.

Medical facility:

The KMCT medical College has a 650 bedded hospital in the same campus that offers excellent medical care to the needs of students and staff of the institution.

There is a provision for a separate Intensive Care Unit and High dependency wards with facilities to manage medical emergencies. The casualty is well equipped and manned to address to the emergencies reporting to the hospital round the clock.

There are specialists from various fields of medicine including Physicians, General surgeons, plastic Surgeons, Orthopaedicians, Pediatricians, Gynecologists, Cardiologists, neurologists and neurosurgeons available throughout the day. Investigations including routine blood work up, biochemical, microbiology, histopathology and radio diagnostic services are available.

Hostel

All the students are offered hostel facilities (separate for boys and girls) with all amenities provided so that they do not miss their home environment and concentrate on their academic career. In addition they are also provided avenues for recreation in the form of in-door and out-door game activities for maintaining a healthy body and mind. There is also a provisional store in proximity to the hostel to meet the day to day needs of the hostel residents We also have the best possible amenities within the campus that will enable the students to have a comfortable living.

Canteen

Canteens are available which provide fresh, nutritious food at concessional rates and cater to the taste of all

the students who come from different parts of the country. There is a separate section of fruit juices, desserts and continental food. The canteens are extremely hygienic with clean cooking and wash areas.

We have state of art equipment in the dental clinics including facilities for dental radiology with in the hospital to provide advanced dental treatment as per the international standards. There is a comprehensive dental clinic which caters the need of medically compromised patients. There is an express clinic for dental emergencies which works in the evenings and on holidays. In addition to these facilities the dental surgeons and faculty also attend to emergencies in the field of maxillofacial surgery and trauma in the clinics at the KMCT medical hospital is located in the same campus.

Hospital:

The KMCT medical College has a 650 bedded hospital in the same campus that offers excellent medical care. It provides the students an excellent learning opportunity and helps them nurture in the field of medicine.

There is a major Operation Theatre complex with 5 operating tables with cutting edge technology and state of art equipment provide excellent treatment facility

There is a provision for a separate Intensive Care Unit and High dependency wards with facilities to manage medical emergencies. The casualty is well equipped and manned to address to the emergencies reporting to the hospital round the clock.

There are specialists from various fields of medicine including Physicians, General surgeons, plastic Surgeons, Orthopaedicians, Pediatricians, Gynecologists, Cardiologists, neurologists and neurosurgeons

available throughout the day. Investigations including routine blood work up,biochemical,microbiology, histopathology and radio diagnostic services are routinely performed here under the supervision of the concerned doctors to provide comprehensive care for the patients.

Labs

The College has a provision for labs that include pre clinical labs in all the basic sciences departments and clinical labs headed by the departments of general pathology and oral and maxillofacial pathology that undertake various medical and histopathological investigations.

The college has preclinical labs with 100 state of the art phantom heads in the department of Endodontics and prosthetic dentistry. This will help the undergraduate student have hands on experience of various dental procedures prior to their clinical postings.

Maintenance of Campus Infrastructure

There are established systems and procedures for maintaining and utilizing physical, academic and support facilities- laboratory, library, sports facilities, computers, classrooms etc. KMCT Dental college has a maintenance committee with members from biomedical department, IT professionals, electricians, civil engineer, plumber who manages the maintenance of physical, academic and support facilities. Meeting is conducted regularly. Budget is allocated as per the requirements after the discussion with the committee. The maintenance check is done periodically which includes daily, weekly, monthly, quarterly and annually

Buildings and Infrastructure maintenance:

Repair works comprises of cleaning, painting, whitewashing, and replacement of inseparable fixtures. Maintenance team under the supervisor checks the repair works of buildings and infrastructure. Daily cleaning of laboratories, class rooms and toilets are done by housekeeping departments.

Machineries:

Institution takes AMC/CMC for costly equipments like CBCT, OPG and intraoral X ray machines, laser units etc. Biomedical department does the regular maintenance and calibration of the machineries. Major faults in the machines are taken care by AMC. In case the equipments break down within the service warranty period, it is returned to the supplier for service or replacement.

Computer facilities:

IT experts ensure trouble free performance of computers and accessories. The maintenance of wifi facilities is outsourced. Updation of hardware and software is done by IT professionals.

Classrooms and Laboratories:

Housekeeping staff maintains the cleanliness of the classrooms. Furniture and electrical fittings are kept under working condition. Repair works of the furniture and electrical items are done after getting service request by the maintenance team and after finishing, log book is entered and approval has to be obtained from engineer. Laboratory technicians/assistants are in charge of maintaining equipments in the Laboratory, any faults or breakdown is reported to the head of the department and repair request is made to biomedical department. Maintenance and repair of physical facilities of the laboratories is done after getting approval by the engineering department.

Library:

Maintenance of books and journals is done by the Library Assistant under the supervision of Assistant Librarian. Shelf rectification is carried out on a daily basis to ensure that the books are in proper order and find the misplaced books. Stock verification is done every year. Any lost books and journals which are entered in a register. Torn or worn Books are segregated and sent for binding and repair. Journals are kept

as bound volumes to preserve the information. Weeding out of older and out-dated books by the experts and entered in a register and provision is made to replace the books in the next budget.

EMPLOYEES' STATE INSURANCE SCHEME

The is an integrated measure of Social Insurance embodied in the Employees' State Insurance Act and it is designed to accomplish the task of protecting '**employees**' as defined in the **Employees' State Insurance Act, 1948** against the impact of incidences of sickness, maternity, disablement and death due to employment injury and to provide medical care to insured persons and their families. The Employees of the college drawing wages upto Rs. 21,000/- a month, are entitled to social security cover under the ESI

Act.

PROVIDENT FUND SCHEME

A provident fund is a government-managed, mandatory retirement scheme. A worker gives a portion of his/her salary to the provident fund, and an employer should make a contribution on behalf of the employees. As per the rules, in EPF the Employees drawing less than Rs 15,000 per month have to mandatorily become members of the EPF and employee whose 'pay' is more than Rs 15,000 a month at the time of joining, is not eligible and is called non-eligible employee. 12 percent of the salary must go towards provident fund.

DENTAL INSURANCE

Dental Insurance is common for all employees. The effective date for the employee is the successful completion of one year of probation period.

HEALTH INSURANCE (Optional)

Health insurance is optional to all employees those who have successfully completed of one year of probation period.

OTOLARYNGOLOGY & VISION CARE PLAN (Optional)

The Otolaryngology &Vision Care Plan is designed to encourage maintenance of vision, throat, nose and ear through regular examinations and to help with expenses.

OBSTETRICS AND GYNECOLOGY PLAN(Optional)

Obstetrics and gynecology planis designed to support regular gynecology examinations of females above 40 years of ageand to provides 30% reimbursement of the total cost of the treatments in KMCT women and child hospital. The institution follows the guidelines for maternity leave as per ESI SCHEME.

MATERNITY LEAVE (UNPAID)

Those employees who have not covered under ESI scheme are eligible to take unpaid leave of 26 weeks for maternity with prior permission from the Principal and HR Manager with medical records.

STAFF ACCOMMODATION

Institution provides accommodation such as apartments and hostels in the campus for needed employees.

SECURITY:

The campus is monitored by CCTV and there is full time uniformed guards inside the campus.

BANK.

Institutional strategies for mobilization of funds and the optimal utilization of resources

Financial Resources

The funds are necessary for the procurement of facilities, equipment, electronics and communication gadgets. Funds are also needed to pay the salaries of administrative, academic and non-academic staff. Plan and policy implementation are responsive to funds availability. Funds are needed for the acquisition of fixed and current assets and to settle current liabilities and expenditure incurred in the course of administration.

The Board of Directors appoints an internal audit committee comprising of Finance Manager, Chief Accountant and accounting staff of corporate office of the trust (KMCT). The accounts of the college are maintained digitally using Tally ERP accounting software. The daily transactions of the institution is monitored and verified on weekly basis. The internal audit committee conducts an internal audit operations. The internal audit committee also establishes a co-ordination of internal and external audit operations. The internal auditing team should report the deficiency to the management. This helps the management to analyse and get a clear picture on the financial status of the institution and to ensure corrective measures on the deficiency. The internal audit committee makes modification on financial data and accounting statements in consultation with the management. The internal auditing has the following process:

- Knowledge of the trust deed and regulations
- Examine the previous financial statements and provision in detail
- Assessment of Internal control system and its flaws
- Verifications of student's fee registers (BDS, MDS), Day book Register and maintaining other regulated records in Tally ERP.
- Verification of fees concessions, and its approvals & policies
- Verification of the statutory payments to different bodies like EPF, ESI, TDS, Income Tax etc.
- Verification of the Bank pass book, e transactions (POS, RTGS, UPI etc.)& reconciliation statement.
- Verification of Grants, scholarships, deposits, payments, salary, remuneration etc.
- Verifying Central store purchase, stock and Interdepartmental stock checking reports.

EXTERNAL AUDIT:

External audit is carried out in an elaborate manner on yearly basis by external auditors, M/s RGN Price & Co, Chartered Accountants. External auditors take care of Financial Statement of Income and Expenditure, Balance Sheet & Income Tax returns Filing, Coverage of GST, TDS & other statutory bodies. Every year audit reports are filed with Income Tax department and placed with supporting documents of the respective year.

Strategies used:

- Handing over to private agency

1. Solid waste:

Paper waste is shredded and sold to licensed purchasers for recycling. Wet and biodegradable waste generated in the campus such as food waste and dry leaves, are centrally dumped into compost pitsand no burning of waste in the campus is permitted or promoted.Proposal for converting Food Waste into Bio Mass is underway. Students of KMCTDC are encouraged to participate in 'Swachh Bharat Abhiyan' India's biggest cleanliness drive.

2 .Liquid waste:

All the liquid waste is released into a soak pit/septic tank, which does not pollute/contaminate the surroundings.

3. Bio medical waste:

Management of Bio hazardous waste is undertaken seriously and is monitored by IQAC. The biomedical waste generated during the diagnosis, treatment, immunization, and laboratory procedures are collected in appropriate Color coded containers. Color coding guidelines for waste disposal is followed at KMCT and students as well as staff are encouraged to dispose waste accordingly. Posters depicting color coding are kept near dustbins for proper waste disposal. Institute has hired a professional agency IMAGE for managing the Bio hazardous waste.

4. E waste:

Some of the old computers are repaired and reused. Some of the repaired computers are donated to under privileged school kids. Computer batteries are disposed off or exchanged through local dealers. Damaged E waste dealt through private agency (Green Worms Eco Solutions LLP).

5. Waste recycling:

Waste water recycling unit recycles the sewage water which is used for watering the plantations. The organic waste undergoes composting and the resultant compost is used as manure for the plants and trees in the college premises.

Best practice 1: "Palliative care" in association with Institute of Palliative Medicine (IPM), Calicut

Our institute believes in helping the people who are terminally ill by providing both mental and medical support. Hence, theDepartment of Public health Dentistry, KMCT Dental college has been conducting training for interns of our institute, in collaboration with Institute of Palliative Medicine (IPM), Calicut since 2018.

Institute of Palliative Medicine is the first centre for Community Participation in Palliative Care and Long Term Care; which WHO is collaborating with and helps in spreading "Kerala model" of Palliative care worldwide. Hence our college considers this as a great oppurtunity, so that Internsof KMCT Dental College can learn the palliative care practices effectively and cultivate a mentality to help the people who are terminally ill.

Objectives of practice:

- 1. To provide palliative care to the patients with life threatening diseases.
- 2. To improve the quality of life of the patients and that of their families who are facing challenges associated with the illness.
- 3. To reduce the unnecessary hospital admissions of the patients by doing intermittent home visits.
- 4. To prepare ourInterns a better human being by providing them an oppurtunity to help the people who are critically ill.

The context :

- Palliative care aims to improve the quality of life of a patient with life threatening disease.
- Early delivery of palliative care is important, so that the unnecessary hospitalization can be

minimized.

• The help provided by the volunteers must be regular and a team has to be set for this purpose.and must have a sense of humanity and empathy.

:

The interns who are posted in the Department of Public health Dentistry of our institute will be sent for posting in IPM, Calicut; on a regular rotation basis for the entire year with duration of 1 week for each batch. Each batch usually consists of 2 to 3 interns and it is compulsory to attend the 7 days and if incase missed in between, they must compensate it later and then only completion certificate will be issued by the IPM institute.

There will be bothOut-Patient and In-Patient postings in the palliative center and each Intern will be directed by a Doctor of IPM. In OP area, they will be doing all examinations needed and prescribing the medicines under the guidance of the IPM team. In the IP sessions, Interns will be going for regular check ups with the IPM team and in a week, one to two home visists also will be done for terminally ill patients.

Evidence of success :

The interns of KMCT Dental college who attended posting in Institute of Palliative Medicine, Calicut gets trained in Palliative care and medicine and they learn how to deal with the terminally ill patients in an appropriate manner.

Problems encountered and Resources required :

Initially we encountered delay to get permission from the IPM Authority and to get a working plan for our interns and later on the issue got solved and posting went smoothly.

Best practice 2:

Joint initiative by KMCTDC & UL Care Nayanar Sadanam

KMCT Dental College has started a joint initiative with 'UL Care Nayanar Sadanam'(ULCCS), to nurture the employability of intellectually challenged adults to help them to attain self sufficiency by training them to practise various activities so that they learn to to perform their daily routine by themselves and this gives them a state acceptancy within the family society.

Objectives of practice:

- 1. To provide oral health awareness sessions to the inmates.
- 2. To conduct Dental health screening and treatment camps for students, cartakers and staffs.
- 3. To provide vocational training and job placements for the students(inmates).
- 4. To train the faculty on management of intellectually challenged group.

The context :

• The collaboration of a dental institution with a foundation where intellectually challenged adults are been trained for their self betterment, can uplift the oral health awarness among the inmates.

- Rehabilation and skill development will be more effective in trainable age group of above 18years.
- The faculties of our institution will get an oppurtunity to get trained by the experts from ULCCS.
- Oral health awarness and hands-on training programmes by our institution; will help them to improve their oral hygiene.
- We train the cartakers and staff members of ULCCS on different brushing techniques.
- The in-house free oral health screening and treatment camps conducted will be very much beneficial for all the inmates. If any tedious procedure is needed, the inmate will be refferd to the dental college, for the same.

The Practice:

Our Institute and ULCCS has initiated a joint effort by conducting various dental screening and treatment camps for the inmates of ULCCS, so that we can we can mould their skill in certain vocational areas, which will help them to improve their quality of life. The initiative has been a grant success, since we made sure that they get placed in our campus. This helps them to make an earning of theirown. The dental screening camps conducted turned out so effective because, we could diagnose many initial lesions and preventive measures were taken accordingly. We have trained them to perform certain oral hygiene measures to include it in their daily hygiene practice. Our staff members who had attended the home visit, also got benefited by receiving the training in managing the intellectually challenged individuals.

Evidence of success :

We have received a lot of appreciation from ULCCS for the interest we showed for this joint initiative. Inmates, staffs and caretakers were so delighted by receiving the best in-housefree dental treatment. The ULCCS members arrange a thanksgiving ceremony after each visit, where they appreciate the effort our institution takes.

Problems encountered and Resources required :

Initially our Public Health Department faced issues regarding getting approval from ULCCS. Later when we explanied the MOU with ULCCS authority, the were delighted to cooperate with our institute. After the first visit itslef, we were appreciated for our effort they welcomed us to conduct more sessions in the future.

Tribal Dental Camps

Introduction:

India, after African nations, has the world's second-largest tribal population and is home to roughly half of the world's autochthonous people, resulting in a diverse range of tribes with interesting and varying backgrounds, traditions, and social practises. Tribal community is the political, ethnic or ancestral division of ancient states and cultures and among whom leadership is typically neither formalized nor permanent, hence they remain underprivileged. The use of health care may be reinforced or inhibited by ethnic attitudes and traditions, and research has found that low socioeconomic and ethnic minority populations are less likely to use health services. They have also been found to be malnourished, with many of them engaging in unhealthy habits such as smoking and drinking.

Such habits can be harmful to one's overall health as well as contribute to the degradation of oral health, including periodontal tissues and oral mucosa. As a result of dental disease and a lack of knowledge about oral health, teeth are extracted leading to a compromised life.

Aim of the initiative:

The aim of this initiative is to reach out to tribal people around Kozhikode district, who are often geographically separated and financially disadvantaged when it comes to seeking dental care. The initiative further seeks to provide healthcare providers with an understanding of the health disparities that tribal people face.

So, it is our duty as a citizen of this country to cherish the culture and protect the people who still living the system. Hence our institute has taken a step forward to help the tribal community by providing them free checkup and treatment by conducting camps. If needed we arrange transport for them to reach our clinic at dental college for further lengthy treatment procedures.

By this these underprivileged people gets awareness about dental and oral health and hence we can improve their quality of life.

Practice:

As a part of Internship programme, Department of Public Health Dentistry, KMCT Dental College have been conducting multiple tribal dental camps within the Calicut city since 2015. We selects tribal colonies either independantly or by the requisition from the respective wards. It has been a great initiative from our side, so that the economically weaker and socially underrated people can get access to dental check ups and treatment which is of free cost. We have providing treatments like Oral prophylaxis, Restorations and extractions. Other advanced procedures will bereffered to KMCT Dental college itself will be dealt with it at free of cost. The transport facility will be provided by the college. The list of interns and staffs who are posted for each camps will be published in the college at a prior notice. As the Department of Public Health Dentistry is having a Mobile Dental Van, that is also taken to the treatment camp site for providing the patients a better treatment and facility. The interns have been getting more exposure in dealing with patients with limited facilities, especially in check up camps.

8.1.2 The Institution ensures adequate training for students in pre-clinical skills

Response:

The preclinical works are meant to train the students with both theoretical and applied practical knowledge before entering the clinics. The course is based on "patient simulation training"

It starts right from the first year with practical classes in Anatomy(both gross and microscopic), physiology, Microbiology and pathology.

Dental science oriented preclinical training include orthodontics, conservative dentistry, dental materials and dental anatomy and dental histology. Preclinical laboratories are setup in the corresponding department to carry out patient simulation courses according to the university prescribed facilities.

Dental anatomy part includes carving of the teeth from wax blocks to study about the morphology of teeth in all the dimensions, both primary and permanent. Various carving competition are conducted to make it enjoyable to students.

Prosthodontic training includes impression making, custom tray fabrication and artificial teeth setting for complete dentures and designing removable dentures. Students are split into groups with a leader for each group, to help them better.

The conservative department has got mannequins to train the students to fill the tooth inside the oral cavity. Knowledge is imparted with the help of drawings, pictures and video.

The orthodontic department trains in various wire bending exercises, which gives the student, a good exposure in handling various thickness of stainless steel wires ranging from19 gauge to 24 gauge for making springs, clasps and labial bows. After the wire bending exercises, various removable appliances are taught to fabricate.

A student record is maintained by the students in all departments, where they prepare and write the notes of preclinical works . Along with it the efficiency and attitude towards the work is graded.

Each of the steps is demonstrated in all the department and in the process of preclinical work, guidance, support and constant motivation is provided for students. This help to develop enthusiasm and keen interest among the students for dentistry.

Theory exams

All the students must prove that they are eligible for university theory exams by scoring at least 50% marks in internal examination. The internal exam is conducted in the exam hall as per the university regulation and question papers are prepared in such a way that it covers are important areas.

Practical examination

Both preclinical and clinical exam comes under this. The practical exam is designed to assess the application of the theory knowledge .

Viva voice

Viva voice helps the student to be assessed on an individual basis. The deep knowledge they have acquired can be assessed as per the interest of the examiner. Viva voice is conducted both as formative (day to day basis) and also for both internal and university examination. This will surely eliminate any mild chance of luck favoring a non-eligible student to easily pass through the exam.

Seminar presentation

Students are allotted a seminar topic in all subjects, which is presented at the time of clinical posting in respective departments. Seminar sessions are not only meant to assess their subject knowledge but also their presentation skills and reasoning ability

Formative methods

Assignments

Various assignments are allotted to students to guide them in learning the subject. The assignment are related to the clinical work which is written by referring standard textbooks and journals and submitted for valuation to the teachers.

Group discussion

A topic is allotted to students and they are given time to read well and understand the topic, make their own notes and after this, each student present this topic in a small group and then a group discussion is carried out on that particular topic in detail.

Periodic and random class test

Along with periodic class test and end of class question answer session, sometimes, random class tests are also given to assess their familiarity in the subject which will also assist in students to reflect their own deep understanding in the subject.
