
S.No.	Speciality	Seats
1.	Conservative Dentistry and Endodontics	3 to 5
2.	Prosthodontics and Crown & Bridge	3 to 5
3.	Orthodontics & Dentofacial Orthopedics	3 to 5
4.	Pediatric Dentistry	3 to 5
5.	Oral & Maxillofacial Surgery	3 to 5

2. The permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to the verification of the achievement of annual targets as indicated in your scheme. The process of renewal of permission in the increased intake capacity will continue till such time the expansion of its facilities is completed.

3. Any admission made in violation of the above condition will be treated as irregular and action under the provisions of the Dentists Act, 1948 and Regulations made thereunder shall be taken.

4. Discrepancies, if any, may be brought to the notice of Dental Council of India and Central Government.
